

Loaner Vehicle Agreement

This Agreement is made between Extra-Tech Automotive Ltd. (“Extra-Tech”) and the Customer (defined below).

The Customer has requested the use of a loaner vehicle (“Vehicle”) while the Customer’s vehicle is being repaired; and,

Extra-Tech is willing to loan the Customer a Vehicle subject to the terms and conditions of this Agreement.

The Customer agree as follows:

1. Insurance and Liability

I hereby agree to entirely assume sole and absolute responsibility for any damage to the Vehicle described above and owned by Extra-Tech and agree to indemnify and hold Extra-Tech harmless from and against any and all damages, loss, expense, fee and/or claim resulting from or relating to the operation of the Vehicle while it is in my possession or under my control. I hereby release Extra-Tech, its directors, officers, shareholders, employees, and any related entities from liability for any damages or injuries caused to anyone or anything involving the Vehicle. I also agree to defend Extra-Tech from any claims arising from my use of the Vehicle.

For purposes of primary liability insurance coverage, I agree that primary coverage will be provided by my insurance policy as outlined in the Alberta Standard Automobile Policy S.P.F.#1. I confirm I have motor vehicle liability insurance coverage valid in the Province of Alberta in a minimum amount of \$1,000,000 per occurrence, as well as comprehensive collision coverage, that is sufficient to provide primary first vehicular coverage against any and all losses, damages, expenses, fees and/or claims.

2. Licence and Operation of the Vehicle

I agree that:

- I possess a valid Alberta driver’s licence and am authorized under Alberta law to drive the Vehicle.
- I will not allow the Vehicle to be loaned, rented or driven by any other person, except my spouse.
- I will not to smoke in the vehicle or operate the vehicle while under the influence of alcohol or drugs and will always operate the Vehicle in a safe and legal manner.
- I will be responsible for the payment of any traffic, parking or other tickets or offenses occurring while I use the Vehicle.
- I will return the Vehicle with the same fuel level that is marked above or be charged **\$2.00 per litre** needed to match the outgoing fuel level.

- I will reimburse Extra-Tech, its directors, officers, shareholders, employees, and any related entities from any claims against Extra-Tech arising out of my use of the Vehicle
- I hereby authorize Extra-Tech to draw upon my credit card for the purpose of reimbursing for any costs I am required to pay under this Loaner Vehicle Agreement.
